

## Land Registration Research

Risk Management in Searching for Boundary Evidence



This 3-hour CPD product is an outgrowth from the 1.5 hour presentation "*Risk Management in Searching for Boundary Evidence in the Electronic Land Registration*" delivered by Anne Cole and Izaak de Rijcke at the AOLS AGM in February, 2020. - 1. The Professional Context webinar sets the frame of reference by addressing:
  - What does society expect?
  - What professional duties apply to research?
  - What are the potential liabilities in research?
  - What needs to be taken into account when searching for evidence of a boundary creating event?
  - Why does it help to "stay curious"?
- **2.** The Overview of the ELRS webinar describes the ELRS and its relationship to both current and historical records by addressing the following:
  - What happened with conversion and automation and why?
  - What are the components of the ELRS?
  - What does a surveyor need to know about an LTCQ parcel?
  - How to find evidence of a boundary creation event in the ELRS?

- **3.** The Best Practices webinar explores some risk-minimizing practices by addressing the following:
  - What is being searched for?
  - Why is knowing the current owner and the current description rarely enough?
  - How is research driven by reconciling the records to the ground and vice versa?
  - What are some red flags in boundary research?
  - How can the historical evidence of boundary creation be found in the ELRS and "behind" the ELRS?
